On October 23, 2023, the Secretariat of Energy in Mexico (Secretaría de Energía en México or SENER) officially issued the "Decree establishing measures to counteract the proliferation of illicit fuel activities linked to the importation of commodities overseen by the Ministry of Energy."

The Decree enforces a temporary restriction on the importation of goods falling under the 68 tariff items specified in the General Law of Import and Export Taxes (La Ley de los Impuestos Generales de Importación y de Exportación). This comprehensive list encompasses items such as jet fuel, fuel oil, fuel additives, and lubricants. The stated objectives of the change are to 1) prevent impending harm to health and the environment; 2) safeguard the health and safety of communities residing near fuel handling centers; and 3) mitigate adverse effects on private vehicles and public transportation systems.
