

## DIRECTOR, GOVERNMENT AFFIARS POSITION DESCRIPTION

The Director, Government Affairs will work within a four person Government Affairs department avocating on behalf of the automotive aftermarket with federal and state legislators and relevant regulatory agencies. This position will work collaboratively across silos to accomplish goals.

This position can be performed remotely from within the DC metro area and does require periodic travel on Capitol Hill and to association events.

## **Primary Responsibilities:**

- Research and prepare policy papers on areas of substantive interest for the aftermarket (e.g. hydrogen fuels vs. EVs) and develop strategies for gaining public support for such policies.
- Monitor and manage state legislation and regulations impacting the auto care industry.
- Prepare external communications with Association members to update the members on Government Affairs activities and solicit input when necessary.
- Participate in federal legislative efforts as necessary to advocate on behalf of the auto care industry.
- Develop and grow relationships with applicable regulatory agencies.
- Participate in the Auto Care Association Government Affairs Committee, including interacting with members, developing agendas, and otherwise supporting the work of the committee.
- Develop and provide presentations to industry and government audiences on association legislative and regulatory initiatives.

- 5-7 years of Government Affairs experience on Capitol Hill and/or with a trade association
- Strong writing, editing, and oral presentation skills
- Proficiency with Microsoft Office and related professional applications
